### **PARKING PERMIT APPLICATION DIRECTIONS FOR SENIORS:**

#### **HOW TO OBTAIN A SENIOR PARKING STICKER:**

1. Download a **Senior Parking application** from the Sachem North homepage and return it back to Room A114 or send it via email to [sdenobrega@sachem.edu](mailto:sdenobrega@sachem.edu) along with a copy of your **Class D Senior License, Registration Card, Insurance Card**, and signed **Teen Safe Ride contract**. If you do not have the Teen Safe Ride contract from last year's Teen Safe Driving assembly, you can summarize any Teen Safe Driving article.
2. All applications will be screened by Administration.
3. Students applying in the summer will be notified in August, if they are to receive a sticker. This notification will specify dates when stickers will be distributed.
4. If you are approved, there is a \$20.00 **non-refundable** fee payable in cash, check, or money order. Checks/money orders are to be made out to "**Sachem High School North.**"

#### **PARAMETERS FOR RECEIVING A PARKING STICKER:**

Student applications for parking stickers will be reviewed to determine eligibility by the following standards:

1. Academic performance (students must be in good academic standing).
2. Student's attendance, tardies, and class cuts during their junior year.
3. Student's behavior in their junior year will be considered.
4. Validity of license (i.e.: senior "D" class license only).
5. Teen Safe Driving contract or Teen Safe Driving article summary.

#### **HOW A PARKING STICKER MAY BE REVOKED:**

1. Course failure (reviewed each quarter).
2. Receiving a "DC" (Denied Credit) in any course.
3. Suspensions or serious infractions.
4. Chronic lateness to school.
5. Failure to adhere to parking regulations, unsafe operation of a vehicle, or improper use of parking sticker (i.e.: switching to another vehicle, copying, or altering a sticker, or transferring to another individual).
6. Failure to comply with either signs and/or directives of security guards, teachers, or administrators.
7. Leaving campus without authorization.
8. Transporting students off campus prior to 9<sup>th</sup> period dismissal who are unauthorized to leave.
9. Allowing any other student to operate your vehicle.

#### **ONLY QUALIFYING SENIORS ARE ELIGIBLE TO PARK ON SCHOOL GROUNDS**
