1. MINI CONTRACTS CONSENT AGENDA FOR ACTION ITEMS 5.1.1. THROUGH 5.1.8. Upon the recommendation of the Superintendent of Schools, a MOTION was made by Mr. Scavo, and seconded by Ms. Wottawa, and approved unanimously (6-0), to approve the consent agenda for action items 5.1.1. through 5.1.8.

#### 5.1.1. Approval of Agreement with Taylor Publishing Company 2017

Upon the recommendation of the Superintendent of Schools, a **MOTION** was made by Mr. Scavo, and seconded by Ms. Wottawa, and approved unanimously (6-0), to approve the agreement between the Sachem Central School District and Taylor Publishing Company for providing Class of 2017 Yearbooks for Sachem High School North. The estimated cost for this service is \$36,500 for 500 copies paid for by the students. This agreement has been reviewed and approved by the school district's attorney.

#### 5.1.2. Approval of Agreement with J.J. Stanis and Company, Inc. for Long Term Disability 2016-17

Upon the recommendation of the Superintendent of Schools, a **MOTION** was made by Mr. Scavo, and seconded by Ms. Wottawa, and approved unanimously (6-0), to approve J.J. Stanis and Company, Inc. for Third Party Administrative Services for the self-insured employee long term disability benefit plan. Sachem SD shall pay an administrative service fee in the amount of fifty dollars (\$50.00) per claim per month. Each claim will be included in the calculation of the amount of the monthly administrative service fee from the date J.J. Stanis receives notice until the claim is closed. The term of this agreement shall be from July 1, 2016 through June 30, 2017. Thereafter, this agreement many be renewed for up to two (2) successive twelve (12) month terms. This agreement has been reviewed and approved by the school district's attorney.

#### 5.1.3. Approval of Tuition Agreement with Bethpage UFSD 2016-17

Upon the recommendation of the Superintendent of Schools, a **MOTION** was made by Mr. Scavo, and seconded by Ms. Wottawa, and approved unanimously (6-0), to approve the agreement between Sachem Central School District and Bethpage Union Free School District to provide educational services to students placed in family homes at board by a social services district or state department or agency and resided at the time in the Sachem Central School District. The rate for this service is derived from Education Law §3202, and related provisions of the Education Law and Regulations of the Commissioner of Education. The term of this agreement shall be from July 1, 2016 through June 30, 2017. This agreement has been reviewed and approved by the school district's attorney.

#### 5.1.4. Approval of Special Education Services Agreement with East Islip UFSD 2016-17

Upon the recommendation of the Superintendent of Schools, a **MOTION** was made by Mr. Scavo, and seconded by Ms. Wottawa, and approved unanimously (6-0), to approve the agreement between Sachem Central School District and East Islip Union Free School District to provide special education services to parentally-placed students with disabilities, when such students attend private schools in the East Islip Union Free School District. East Islip UFSD shall be entitled to bill Sachem CSD for the services provided in accordance with Education Law Section 3602-c and the Regulations or Rules of the Commissioner of Education. The term of this agreement shall be from September 6, 2016 through June 30, 2017. This agreement has been reviewed and approved by the school district's attorney.

#### 5.1.5. Approval of Special Education Providers for Section 611 and Section 619 Grants 2016-17

Upon the recommendation of the Superintendent of Schools, a MOTION was made by Mr. Scavo, and seconded by Ms. Wottawa, and approved unanimously (6-0), to approve the agreements for receipt of IDEA Flow-Through Funding between Sachem Central School District and Adults and Children with Learning and Developmental Disabilities, Inc., AHRC-NYSARC, Inc. Suffolk Chapter, Alternatives for Children, Ascent: A School for Individuals with Autism, Astor Day Learning & Treatment Center, Bilinguals Inc./Child & Parent Service, Brentwood UFSD, Building Blocks Developmental Preschool, Cleary School for the Deaf, County of Suffolk, Dept. of Health Services, Div. of Svcs. for Children with Special Needs, Developmental Disabilities Institute, Just Kids Early Childhood Learning Center, Kidz Therapy Services, PLLC, Leeway School, Maryhaven Center of Hope, Metro Therapy, Inc., The New Interdisciplinary School, New York Therapy Placement Services, Inc., The Opportunity Pre-School, Pathfinder Village School, St. Anne Institute, Tyree Learning Center (SCO Family of Services), United Cerebral Palsy Assoc. of Greater Suffolk, Inc., Westbrook Preparatory School (SCO Family of Services) and Woods Services as special education providers for the 611 and 619 grants. The costs associated are in accordance with the IDEA section 611 and section 619 federal funds consistent with federal and state statutes. The term of these agreements shall be September 1, 2016 through June 30, 2017 for a ten (10) month program or July 1, 2016 through June 30, 2017 for a twelve (12) month program. These contracts have been reviewed and approved by the school district's attorney.

#### 5.1.6. Approval of Related Services Agreement with All About Kids 2016-17

Upon the recommendation of the Superintendent of Schools, a **MOTION** was made by Mr. Scavo, and seconded by Ms. Wottawa, and approved unanimously (6-0), to approve the agreement between Sachem Central School District and All About Kids to provide related services for its students with handicapping conditions consisting of, but not limited to the following:

In full consideration for the services to be rendered, the District agrees to pay at the rates set forth in Appendix "A" to this agreement. This agreement shall be in effect from July 1, 2016 to June 30, 2017. This contract has been reviewed and approved by the school district's attorney.

#### 5.1.7. Approval of Academic Tutoring Agreement with All About Kids 2016-17

Upon the recommendation of the Superintendent of Schools, a **MOTION** was made by Mr. Scavo, and seconded by Ms. Wottawa, and approved unanimously (6-0), to approve the agreement between Sachem Central School District and All About Kids to provide academic tutoring services

in accordance with the State Education regulations, using only teachers certified by the New York State Education Department. The rates for home instruction/tutoring are \$70.00 per hour. This agreement shall be in effect from July 1, 2016 to June 30, 2017. This contract has been reviewed and approved by the school district's attorney.

#### 5.1.8. Approval of Agreement with Variety Child Learning Center 2015-16

The District will pay for each child, the tuition rate set by the State Education Department. This agreement shall be in effect for the period July 1, 2015 to June 30, 2016. This contract has been reviewed and approved by the school district's attorney.
