#### 1. Bid Awards

### Consent Agenda for Action Items D.1.a. through D.1.f.

- 1. Mini- Contracts
  - 1.a. <u>Approval of Agreement Between Sachem Central School District and</u> <u>Riverhead Central School District</u> RECOMMENDED ACTION: "that, upon the recommendation of the Superintendent of Schools, the Board of Education approves the agreement between Sachem Central School District and Riverhead Central School District to provide health and welfare services to students who reside in the Sachem Central School District. The rate for this service is \$643.94 per student. The term of this agreement is from September 2006 through June 2007. This agreement has been reviewed and approved by the school district's attorney."

## 1.b. <u>Approval of Agreement Between Sachem Central School District and NY</u> <u>Party Works</u>

RECOMMENDED ACTION: "that, upon the recommendation of the Superintendent of Schools, the Board of Education approves the agreement between Sachem Central School District and NY Party Works, Inc. for Sagamore Middle School to lease equipment for a carnival on Friday, October 19, 2007 at a cost of \$1,750.00. This is being paid for by the students out of the Student Government account. This contract has been reviewed and approved by the school district's attorney."

### 1.c. <u>Approval of Agreement Between Sachem Central School District and</u> <u>Agostino Arts</u>

RECOMMENDED ACTION: "that upon the recommendation of the Superintendent of Schools, the Board of Education approves the agreement between Sachem Central School District and Agostino Arts to provide face painting and story telling on ESL Community Night to be held on November 7, 2007. The fee for this is \$750 being paid for by the Title III ESL Grant. This contract has been reviewed and approved by the school district's attorney."

#### 1.d. <u>Approval of Agreement between the Sachem Central School District and</u> <u>Tams-Witmark Music Library</u>

RECOMMENDED ACTION: "that upon the recommendation of the Superintendent of Schools, the Board of Education approves the agreement between Sachem Central School District and Tams-Witmark Music Library, Inc. for the Sachem High School North to rent items for a school play entitled "Camelot." The cost for this service is \$1,145.00 and \$825.00 for each additional consecutive performance. This will be paid for by the district. This contract has been reviewed and approved by the school district's attorney."

#### 1.e. <u>Approval of Agreement between the Sachem Central School District and</u> <u>GBC Technical Support and Service</u>

RECOMMENDED ACTION: "that, upon the recommendation of the Superintendent of Schools, the Board of Education approves the agreement between Sachem Central School District and GBC Technical Support and Service for equipment maintenance for an Ultima65-1 Laminator at Gatelot Elementary School. The cost of this service is \$323.00 to be paid through a Sachem Central School District Purchase Order. The agreement shall expire on June 30, 2008. This contract has been reviewed and approved by the school district's attorney."

#### 1.f. <u>Approval of Agreement between the Sachem Central School District and</u> <u>Camelot Party Rentals</u>

RECOMMENDED ACTION: "that, upon the recommendation of the Superintendent of Schools, the Board of Education approves the rental of inflatable items from Camelot Party Rentals for the Sachem High School East homecoming event to be held on Friday, October 12, 2007. The cost for this service is \$1,362.75 to be paid for out of the student government account. This rental has been reviewed and approved by the school district's attorney."

### 2. Approval of Authorization for School District Attorney to Commence Litigation

**RECOMMENDED ACTION:** "that upon the recommendation of the Superintendent of Schools, the Board of Education approves the following resolution:"

BE IT RESOLVED, that the school district attorney is authorized to commence litigation to recover from the Mt. Sinai School District for health services incurred during the 2006-07 school year in the total amount of \$670.73.

## 3. Creation of Dispatcher Position
