### 1. Mini- Contracts

### 1.a. <u>Approval of Agreement Between Sachem Central School District and</u> <u>Music Theater International (MTI Theatrical Resources) - Seneca</u>

RECOMMENDED ACTION: "that, upon the recommendation of the Superintendent of Schools, the Board of Education approves the agreement between the Sachem Central School District and Music Theatre International (MTI Theatrical Resources) to provide performances in the 2007-2008 school year of Once on this Island Junior. The cost for this service is approximately \$800.00 to be paid by the district out of the drama budget code. This is for the Seneca Middle School. This company is the only one that holds the rights to this play. This contract has been reviewed and approved by the school district attorney."

### 1.b. <u>Approval of Agreement Between Sachem Central School District and</u> <u>Lenore Dillon</u>

RECOMMENDED ACTION: "that, upon the recommendation of the Superintendent of Schools, the Board of Education approves the agreement between Sachem Central School District and Lenore Dillon to provide staff development workshops regarding Tourette Syndrome. She previously addressed the Sachem staff and is extremely knowledgeable on this topic. The rate for this service is \$350.00 per three (3) hour workshop. This contract shall be in effect for the period October 15, 2007 through June 30, 2008. This contract has been reviewed and approved by the school district's attorney."

#### 1.c. <u>Approval of Agreement Between Sachem Central School District and</u> <u>SCOPE – Sexual Harassment Workshops</u>

RECOMMENDED ACTION: "that, upon the recommendation of the Superintendent of Schools, the Board of Education approves SCOPE to provide Sexual Harassment Workshops district-wide beginning December 4, 2007 through March 6, 2008. The cost of these workshops is \$350 per session for a total cost of \$6,300.00. This is being paid for by the Federal Funds Office. This workshop is mandated for each employee of the Sachem Central School District."

### 1.d. <u>Approval of Agreement Between Sachem Central School District and</u> <u>AJK Diversified</u>

RECOMMENDED ACTION: "that, upon the recommendation of the Superintendent of Schools, the Board of Education approves the agreement between Sachem Central School District and AJK Diversified for a presentation titled "The Bullying to Hate Crime Continuum." The cost for this lecture is \$500.00. This was held at Sachem High School East on November 28, 2007. Patti LeBlanc attended the Council for Prejudice Reduction conference. AJK Diversified addressed issues of diversity prejudice, and the need for respect and tolerance in our school and community. Since this is the main focus of Project SPECTRUM(Sachem Promotes Equity, Cooperation, Tolerance, Respect, Unity, and Mediation), Ms. Keneth was able to offer a presentation that reinforced character education. In addition, she is highly recommended by Bette Ingoglia. This contract has been reviewed and approved by the school district's attorney."

### 2. Approval of Settlement –Student # 100644

RECOMMENDED ACTION: "that, upon the recommendation of the Superintendent of Schools, the Board of Education approve the following resolution:"

BE IT RESOLVED, that the Board of Education hereby authorizes the Superintendent of Schools to enter into a stipulation of settlement involving an impartial hearing pertaining to student # 100644.

SACHEM CENTRAL SCHOOL DISTRICT" venue in the New York State Supreme Court, County of Suffolk, Index No. 05/27854 in accordance with the terms of the Stipulation of Settlement between the parties; and,

BE IT FURTHER RESOLVED: "that the Board of Education hereby authorizes the Board President to execute any and all documents necessary to effectuate said settlement."

#### 6. Settlement of SAV-Mor Mechanical v. Sachem Central School District

RECOMMENDED ACTION: "that, upon the recommendation of the Superintendent of Schools, the Board of Education approve the following resolution:"

BE IT RESOLVED: "that the Board of Education of the Sachem Central School District hereby authorizes settlement of the action titled "SAV-MOR MECHANICAL INC.. v. SACHEM CENTRAL SCHOOL DISTRICT" venue in the New York State Supreme Court, County of Suffolk, Index No. 06/01636 in accordance with the terms of the Stipulation of Settlement between the parties; and,

BE IT FURTHER RESOLVED: "that the Board of Education hereby authorizes the Board President to execute any and all documents necessary to effectuate said settlement."

#### 7. SEQRA Resolution

RECOMMENDED ACTION: "that, upon the recommendation of the Superintendent of Schools, the Board of Education approve the following resolution:"

WHEREAS, the Board of Education of the Sachem Central School District desires to embark upon the capital improvement project Lynwood Avenue Elementary School Gym Curtain; and

WHEREAS, said capital improvement projects are subject to classification under the State Environmental Quality Review Act (SEQRA); and

WHEREAS, routine activities such as renovations to, or expansions of existing public school facilities by less than 10,000 square feet are classified as Type II Actions under the current Department of Environmental Conservation SEQRA Regulations (Section 6 NYCRR 617.5(8); and

WHEREAS, the SEQRA Regulations declare Type II Actions to be actions that have no significant impact on the environment and require no further review under SEQRA; and

WHEREAS, the Board of Education, as the only involved agency, has examined all information related to the capital improvement projects and has determined that the Lynwood Avenue Elementary School Gym Curtain hereto are classified as a Type II Actions pursuant to Section 617.5(8) of the SEQRA Regulations;

NOW, THEREFORE, BE IT RESOLVED that the Board of Education hereby declares itself lead agency in connection with the requirements of the State Environmental Quality Act; and

BE IT FURTHER RESOLVED, that the Board of Education hereby declares that the Lynwood Avenue Elementary School Gym Curtain hereto are Type II Actions, which requires no further review under SEQRA; and

BE IT FURTHER RESOLVED, that the Board of Education hereby shall forward an official copy of this Resolution to the New York State Education Department together with a copy of the correspondence from the New York State Office of Parks, Recreation and Historic Preservation in connection with its request for approval of said projects from the New York State Education Department.
