Whereas the employee has tendered to the Superintendent a letter memorializing that request and waiver after having had a full and fair opportunity to consult with Union representation and/or Counsel; be

RESOLVED that the Board of Education hereby revokes the conditional grant of tenure which it made to the employee on or about March 18, 2009; and be it further

RESOLVED that the Board of Education and Superintendent accept a letter from the employee dated April 3, 2009 wherein the employee requests and extension of the employees' probationary period pursuant to the terms set forth in that letter
