Shortly after the polls closed at 9 pm, each Chief Election Inspector presented the voting results from each district. The District Clerk reviewed the numbers from all 12 voting machines. The District Clerk announced the following results:

Proposition No. 1: Shall the following proposition be adopted:  
RESOLVED, that the budget for the SACHEM CENTRAL SCHOOL DISTRICT, Suffolk County, New York, for the fiscal year 2012-2013 in the amount of \$291,358,344 as proposed by the Board of Education in accordance with Section 1716 of the Education Law, shall be approved, a tax levied therefor upon the taxable property of said School District. Adoption of this budget requires a tax levy increase of \$6,358,238 that exceeds the statutory tax levy increase limit of 2.8% for the 2012-2013 school year and, therefore, exceeds the New York State tax levy limit including exemptions by 1.4% and must be approved by 60 percent of the qualified voters present and voting.
