d. Approval of Special Education Services Agreement, Bay Shore UFSD 2012-13

Upon the recommendation of the Superintendent of Schools, a **Motion** was made by Mr. Isernia, seconded by Ms. Ahearn, and carried unanimously (9-0) to approve the agreement between Sachem Central School District and Bay Shore Union Free School District to provide special education services to parentally-placed students with disabilities, when such students attend private schools in the Bay Shore Union Free School District, but reside in the Sachem Central School District. Bay Shore UFSD shall be entitled to bill Sachem CSD in accordance with Education Law Section 3602-c and the Regulations or Rules of the Commissioner of Education. The term of this agreement shall be from July 1, 2012 through June 30, 2013.

e. <u>Approval of Health and Welfare Service Agreement-Bay Shore UFSD</u>

Upon the recommendation of the Superintendent of Schools, a **Motion** was made by Mr. Isernia, seconded by Ms. Ahearn, and carried unanimously (9-0) to approve the agreement between Sachem Central School District and Bay Shore Union Free School District to provide health and welfare services to students who reside in the Sachem Central School District. The rate for this service is \$727.59 per student. The term of this agreement is from September 5, 2012 through June 21, 2013.

f. Approval of Agreement with Advanced Psychological Assessment, P.C.

2013-14 School Budget Discussion – Mr. Singer updated the Board on State Aid. There was a consensus of the Board to request the following:

Budget draft with four options -(1) 16.5% increase roll over budget, (2) 12% increase budget, (3) 8% increase budget; and (4) 4.71% budget cap. Include in the four budget drafts recommendations from the administration for budgetary cuts that would least impact the students.

Savings associated with closing middle schools and one high school.

Savings associated with redistricting students: K-6 elementary schools, UPK at Samoset, 2 middle schools, 2 high schools with one high school for grades 9 and 10 and the other high school for grades 11 and 12.

There was a leaning by a majority of the Board not to change the private and parochial school transportation mileage requirement nor the transportation mileage to Sachem schools.
