Consent Agenda

Upon the recommendation of the Superintendent of Schools, a **Motion** was made by Mr. Isernia, seconded by Mr. Tripi, and carried unanimously (8-0) to approve a consent agenda for mini contracts a - f.

a. <u>Approval of Service Plan with Phonak</u>

Upon the recommendation of the Superintendent of Schools, a **Motion** was made by Mr. Isernia, seconded by Mr. Tripi, and carried unanimously (8-0) to approve the service plan between Sachem Central School District and Phonak for the repair and maintenance of equipment used by our hearing-impaired students. The comprehensive service plan covers all Phonak equipment less than 5 years of age and includes loss coverage for eligible units. The cost is \$1,620.00 for seventeen (17) units for the period of July 1, 2013 to June 30, 2014.

b. <u>Approval of Extended Warranty with Oticon</u>

Upon the recommendation of the Superintendent of Schools, a **Motion** was made by Mr. Isernia, seconded by Mr. Tripi, and carried unanimously (8-0) to approve extended warranty coverage with Oticon for the repair and loss and damage of units used by our hearing-impaired students. The cost for this extended coverage is \$2,459.00 for the period of July 1, 2013 to June 30, 2014.

c. <u>Approval of Facilities License Agreement</u>

Upon the recommendation of the Superintendent of Schools, a **Motion** was made by Mr. Isernia, seconded by Mr. Tripi, and carried unanimously (8-0) to approve the Facilities License Agreement between Sachem Central School District and Sienna College for the use of facilities owned by Sienna College. The term of license shall commence on Thursday, March 14, 2013 from 4:00 p.m. to 5:30 p.m. at a total cost of \$150.00. Due to the timing we are asking for approval after the date of the event. This agreement is being reviewed by the school district's attorney.

d. <u>Approval of Agreement with Hilton Garden Inn-Hershey</u>

Upon the recommendation of the Superintendent of Schools, a **Motion** was made by Mr. Isernia, seconded by Mr. Tripi, and carried unanimously (8-0) to approve the agreement between Sachem Central School District and the Hilton Garden Inn-Hershey. This is for an overnight stay on May 31, 2013 for approximately one hundred (100) students at Samoset Middle School attending a music competition. The cost is approximately \$225 per person and is paid entirely by the students.

e. Approval of Health and Welfare Service Agreement with Sayville UFSD

Upon the recommendation of the Superintendent of Schools, a **Motion** was made by Mr. Isernia, seconded by Mr. Tripi, and carried unanimously (8-0) to approve the agreement between Sachem Central School District and Sayville Union Free School District to provide health and welfare services to students who reside in the Sachem Central School District. The rate for this service is \$920.60 per student. The term of this agreement is from July 1, 2012 through June 30, 2013. This agreement has been reviewed and

approved by the school district's attorney.

f. <u>Approval of Agreement with McClave Engineering, P.C.</u>

Upon the recommendation of the Superintendent of Schools, a **Motion** was made by Mr. Isernia, seconded by Mr. Tripi, and carried unanimously (8-0) to approve the agreement between McClave Engineering, P.C. and Sachem Central School District to provide all architectural and engineering services, including but not limited to structural, mechanical and electrical engineering services required to complete the renovation of Chippewa Elementary School Kindergarten. McClave Engineering, P.C. shall designate Patrick D. McClave, P.E. as the Project Engineer in charge of the Project. The Engineer's compensation for the services outlined in Articles 2 through 7 of the agreement shall be \$1,931.84. The term of the agreement shall be for the period April 1, 2012 and shall continue until completion of the work by the Contractors engaged and completion of the services outlined in Article 7. This agreement has been reviewed and approved by the school district's attorney.

Approval of Nurse's Rate for Summer Enrichment Camp

Deduct Change Order No. 2, Xtraire, Inc.

Upon the recommendation of the Superintendent of Schools, a **Motion** was made by Mr. Timo, seconded by Mr. Isernia, and carried unanimously (8-0) to approve a deduct Change Order No. 2 for Xtraire, Inc. for Lynwood Avenue Elementary School. The original contract amount of \$250,000.00 was previously changed to \$245,000.00. This new contract amount will be decreased by \$124,000.00. The contract amount shall be amended as follows:

- Replacement of the kitchen exhaust hood is being removed from the scope of work. The District has elected to change their kitchen equipment under the existing exhaust hood with equipment that will not produce grease laden smoke and therefore, be classified as a Type 2 Hood, which is not required to have a fire suppression system.
 Deduct: \$116,500.00
- An allowance, in the amount of \$7,500.00 was included in the contract documents, for unforeseen conditions. The allowance is being returned in its entirety. Deduct: \$ 7,500.00

The new contract amount including this Change Order will be \$121,000.00. The total amount to be paid is \$6,000.00.

Deduct Change Order No. 1, More Construction & Consulting, Inc.

Upon the recommendation of the Superintendent of Schools, a **Motion** was made by Mr. Isernia, seconded by Mr. Timo, and carried unanimously (8-0) to approve a Change Order No. 1, More Construction & Consulting, Inc. for Sachem High School North, emergency roof repair. The original contract amount of \$98,500.00 will be decreased by \$8,072.93. An allowance was included in the contract documents. An unused allowance in the amount of \$8,072.93 is being returned. The new contract amount including this Change Order will be \$90,427.07.

Deduct Change Order No. 1, Xtraire, Inc.

Upon the recommendation of the Superintendent of Schools, a **Motion** was made by Mr. Tripi, seconded by Mr. Isernia, and carried unanimously (8-0) to approve a deduct Change Order No. 1 for Xtraire, Inc. for Gatelot Avenue Elementary School. The contract amount of \$250,000.00 will be decreased by \$5,000.00. An allowance, in the amount of \$5,000.00, was included in the contract documents, for unforeseen conditions. The allowance is being returned in its entirety. The new contract amount including this Change Order will be \$245,000.00.

Updates to the Board

PRESENTATION/DISCUSSIONS:

2013-14 School Budget Discussion – Associate Superintendent Bruce Singer highlighted his "Notes to Various 2013-14 Budget Options for April 3, 2013 Board Meeting." A question and answer period followed. There was unanimous consensus of the Board to accept Pension Smoothing Teachers' Retirement in order to save \$2,784,605 in this year's budget. However, the District is not locked into Pension Smoothing. The District can opt-out if desired. The Board will discuss in executive session specific personnel matters which may save the District additional monies in an effort to possibly restore kindergarten aides and the GATE program to the proposed budget. There was a unanimous consensus of the Board to have our attorney conduct a title search and appraisal of 245 Union Avenue at a cost not to exceed \$5,000. An official resolution will be voted upon at the next meeting.

The Board requested follow up on the following:

- 1. Breakdown of unemployment costs.
- 2. Details of who will perform the work of the 6 custodians and 2 groundspeople listed in the budget report as being eliminated.
- 3. Budget report on the options should the budget fail to be approved by the voters.
