AGENDA: Upon the recommendation of the Superintendent of Schools, a **Motion** was made by Mr. Coggin, seconded by Mr. Tripi, and carried unanimously (9-0) to approve a consent agenda for mini contracts a-g.

#### a. <u>Approval of Health and Welfare Services Agreement with Middle Country CSD 2015-16</u>

Upon the recommendation of the Superintendent of Schools, a **Motion** was made by Mr. Coggin, seconded by Mr. Tripi, and carried unanimously (9-0) to approve the agreement between Sachem Central School District and Middle Country Central School District to provide health and welfare services to students who reside in the Sachem Central School District. The rate for this service is \$824.11 per student. The term of this agreement shall be from July 1, 2015 through June 30, 2016. This agreement has been reviewed and approved by the school district's attorney.

#### b. Approval of Agreement with Scope Education Services 2015-16

Upon the recommendation of the Superintendent of Schools, a **Motion** was made by Mr. Coggin, seconded by Mr. Tripi, and carried unanimously (9-0) to approve the agreement between Sachem Central School District and SCOPE Education Services for two hundred fifty two (252) four year children to participate in a pre-kindergarten program which will be housed at the Gatelot Avenue, Hiawatha, Chippewa, Tamarac, Waverly, Merrimac, Nokomis, and Wenonah Elementary Schools. The funds for the pre-kindergarten placement are appropriated by grant through the State of New York. The grant amount is \$599,400.00. The term of this agreement shall be from September 1, 2015 to and including June 30, 2016. This agreement has been reviewed and approved by the school district's attorney.

#### c. Approval of Special Education Services Agreement with Half Hollow Hills CSD 2015-16

Upon the recommendation of the Superintendent of Schools, a **Motion** was made by Mr. Coggin, seconded by Mr. Tripi, and carried unanimously (9-0) to approve the agreement between Sachem Central School District and Half Hollow Hills Central School District to provide special education services to parentally-placed students with disabilities, when such students attend private schools in the Half Hollow Hills Central School District, but reside in the Sachem CSD. Half Hollow Hills CSD shall be entitled to bill Sachem CSD in accordance with Education Law Section 3602-c and the Regulations or Rules of the Commissioner of Education. The term of this agreement shall be from July 1, 2015 through June 30, 2016. This agreement has been reviewed and approved by the school district's attorney.

## d. Approval of Special Education Services Agreement with West Islip UFSD 2015-16

Upon the recommendation of the Superintendent of Schools, a **Motion** was made by Mr. Coggin, seconded by Mr. Tripi, and carried unanimously (9-0) to approve the agreement between Sachem Central School District and West Islip Union Free School District to provide special education services to parentally placed students with disabilities, when such students attend private schools in the West Islip UFSD but reside in Sachem CSD. The cost for these services is in accordance with

Education Law Section 3602-c and the Regulations of the Commissioner of Education, Part 177. The term of this agreement shall be from July 1, 2015 through June 30, 2016.

#### e. Approval of Health and Welfare Services Agreement with West Islip UFSD 2015-16

Upon the recommendation of the Superintendent of Schools, a **Motion** was made by Mr. Coggin, seconded by Mr. Tripi, and carried unanimously (9-0) to approve the agreement between Sachem Central School District and West Islip Union Free School District to provide health and welfare services to students who reside in the Sachem Central School District. The rate for this service is \$811.47 per student. The term of this agreement shall be from July 1, 2015 through June 30, 2016. This agreement has been reviewed and approved by the school district's attorney.

#### f. Approval of Agreement with United Cerebral Palsy of Greater Suffolk, Inc. 2015-16

Upon the recommendation of the Superintendent of Schools, a **Motion** was made by Mr. Coggin, seconded by Mr. Tripi, and carried unanimously (9-0) to approve the agreement between Sachem Central School District and United Cerebral Palsy of Greater Suffolk, Inc. to provide instruction to children with disabilities. The cost for each child is the tuition rate set by the State Education Department. In the event evaluations are requested, Sachem School District shall pay in accordance with Appendix A of the agreement. This agreement shall be from July 1, 2015 through June 30, 2016. This contract has been reviewed and approved by the school district's attorney.

#### g. Approval of Agreement with Nassau Suffolk Services for Autism 2015-16

Upon the recommendation of the Superintendent of Schools, a **Motion** was made by Mr. Coggin, seconded by Mr. Tripi, and carried unanimously (9-0) to approve the agreement between Sachem Central School District and Nassau Suffolk Services for Autism to provide adequate instruction, related services and/or a facility to students enrolled at the facility during the school year. The School District will pay, for each child, the annual, twelve (12) month tuition rate of \$85,000. The term of this agreement shall be from July 1, 2015 to June 30, 2016. This agreement has been reviewed and approved by the school district's attorney.

#### Denial of Late Transportation Request for Private and Parochial Schools

Upon the recommendation of the Superintendent of Schools, a **Motion** was made by Mr. Tripi, seconded by Mr. Scavo, and carried unanimously (9-0) to deny the request for late transportation to Our Lady of Good Success in Farmingville for four students at an approximate cost of \$30,540.00 for the remainder of the 2015-2016 school year.

#### **Resolution Approving School Closure**

Upon the recommendation of the Superintendent of Schools, a **Motion** was made by Mr. Coggin, and was seconded by Mr. Tripi to approve the following resolution:

**WHEREAS**, opportunities to realize increased efficiencies within the Sachem Central School District have been under close study by the Board of Education for a number of years; and

WHEREAS, declining enrollment has been a concern of the Board for at least the past five years

as the District struggles to implement costly mandates and continue its operations under the New York State property tax cap; and

**WHEREAS**, as a result of these fiscal constraints, including a loss of revenue totaling over 21 million dollars attributable to the Gap Elimination Adjustment in the 2008-9 school year and an overall decline in District enrollment from 15,006 students in the 2008-9 school year to 13,644 in the 2015-16 school year, with a demographer's projection of a continued enrollment decline to 12,771 students by 2018, the Board of Education has been forced to consider the closure of school buildings; and

**WHEREAS**, in view of the foregoing, pursuant to a duly adopted Board resolution, the Board of Education established the Sachem Facilities Study Committee on September 25, 2013 with the charge to study the educational and fiscal impact of potential school closings and the effective use of school facilities in light of declining school enrollment and budgetary concerns; and

**WHEREAS**, the Facilities Study Committee met on at least ten occasions in public meetings, and as a part of its process of collected and analyzed data, generated a report including Educational Impact as a part of its analysis for the Board's consideration, and conducted at least five presentations to the Board of Education in public hearings for the purpose of updating the Board regarding its work, and providing the opportunity for feedback, suggestions and information from community members; and

**WHEREAS**, the Facilities Study Committee presented its ultimate findings and recommendations to the Board of Education in an Educational Impact Statement on January 22, 2014, inclusive of one of the Committee's proposed options to consider the closure of at least one middle school and two elementary schools in response to declining enrollment; and

**WHEREAS**, the Board of Education declined to act upon the recommendations of the Facilities Study Committee in the 2013-14 school year, deferring the consideration of school closures to a future date; and

**WHEREAS** between December 19, 2012, and the present, the Board of Education has engaged in the public discussion of issues relating to the consideration of school closures including but not limited to data gathering, procedures, demographic data, building configuration and utilization in approximately forty publicly held meetings of the Board of Education in addition to the meetings of the Committee; and

**WHEREAS**, the feedback, suggestions and information provided by the community at the public hearings was reviewed and considered at the meetings of the Board of Education; and

**WHEREAS**, the Educational Impact Statement has been accessible to the public since January 22, 2014; and

**WHEREAS**, the Board of Education decided to revisit the issue of school closures in the 2015-16 school year, utilizing the Educational Impact Statement and supporting information previously referenced, and requested that the professionally trained experts retained by the Board to assist the Committee provide the Board with updated demographic and other data relevant to this analysis; and

**WHEREAS**, at a publicly held meeting of the Board of Education on December 16, 2015 the Board publicly shared and considered the updated demographic information and recommendations of the professionally trained demographer retained to assist the committee and Board; and

**WHEREAS**, beginning on or about January 4, 2016, the Board circulated notices to the community and elected state and local public officials who represent the affected communities that it proposed to close the Tecumseh and Gatelot Elementary Schools, and the Sequoya Middle School; and

**WHEREAS**, after providing the public with the appropriate notice, the Board conducted a public hearing on January 20, 2016 to conduct a public hearing and final evaluation regarding the impact of the proposed closing of the Tecumseh and Gatelot Elementary Schools, and the Sequoya Middle School on the Sachem Central School District;

**NOW, THEREFORE, BE IT RESOLVED**, that the Board of Education approves the closing of the Tecumseh and Gatelot Elementary Schools, and the Sequoya Middle School effective August 31, 2016; and

**BE IT FURTHER RESOLVED**, that the Board of Education will adopt, at a subsequent date, an elementary pupil redistricting plan, which plan is required as a result of the determination of the Board of Education to close Tecumseh and Gatelot Elementary Schools, and the Sequoya Middle School.

#### Approval of Stipulation of Agreement - Non-Instructional Employee

Upon the recommendation of the Superintendent of Schools, a **Motion** was made by Ms. Ahearn, seconded by Mr. Tripi, and carried unanimously (9-0) to approve a Stipulation of Agreement dated December 16, 2015 between the Sachem Central School District and a non-instructional staff member, whose identity has been made known to the Board in Executive Session, regarding a personnel matter.

#### Disciplinary Suspension – Non-Instructional Staff Member

Upon the recommendation of the Superintendent of Schools, a **Motion** was made by Mr. Tripi, seconded by Ms. Ahearn, and carried unanimously (9-0) to adopt the following resolution:

BE IT RESOLVED, that upon the recommendation of the Superintendent of Schools, the Board of Education hereby suspends, without pay, a member of the non-instructional staff, whose identity was disclosed in executive session for a period of five (5) work days. The five day suspension shall be January 26, 27, 28, and February 2, 3, 2016.

#### **Donation - Lake Grove Lions Club**

Upon the recommendation of the Superintendent of Schools, a **Motion** was made by Mr. Tripi, seconded by Mr. Scavo, and carried unanimously (9-0) to accept with gratitude, the donation of Kohl's gift cards totaling \$1,000.00 from the Lake Grove Lions Club. Gift cards were sent to Sachem High School North, Samoset Middle School, Gatelot, Cayuga and Wenonah Elementary Schools to be distributed to families in need as determined by school nurses and social workers.
